Within 10 days of the CLAIMS ADMINISTRATOR's receipt of a compliant Notice of Intent to Sue and the accompanying material described above, the CLAIMS ADMINISTRATOR will forward this form and the accompanying material to all BP defendants named in your NOTICE OF INTENT TO SUE. Within 30 days of receipt of this form and accompanying material, a BP defendant may exercise the option to mediate your claim(s). If a BP defendant decides to mediate your claim(s), you may not file a BACK-END LITIGATION OPTION LAWSUIT against BP or OTHER RELEASED PARTIES unless you complete the mediation process without resolving your claim(s).
